3. DETERMINE QUORUM PRESENT AND CALL MEETING TO ORDER - MAYOR

4. PUBLIC COMMENTS

Miriam Haller presented a letter to the commission regarding the fitness classes for seniors. Stefany Bauer addressed the Commission regarding the cancellation of the city's agreement with the Tu Salud Si Cuenta program.

5. CONSENT AGENDA:

A. <u>APPROVAL OF MINUTES FOR CITY COMMISSION MEETING HELD AUGUST 22, 2023.</u>

Mayor Pro-Tem Guevara made a motion to approve the items under consent agenda as presented. The motion was seconded by Commissioner Garcia and passed unanimously.

6. PUBLIC HEARING ON ZONE CHANGE REQUEST FROM C-2 GENERAL BUSINESS DISTRICT TO PD- PLANNED DEVELOPMENT DISTRICT FOR 16.91 ACRES OUT OF LOT 1, BLOCK 9 BEAKLEY SUBDIVISION.

Mayor Maldonado opened the public hearing at 6:35 pm. Frank Mesa, Josie Ruiz and Robert Marroquin live in the area near the proposed planned development and oppose the rezone request. They cited concerns about drainage and flooding for their opposition. Stefany Bauer stated that the school district could not handle more students and therefore opposes the zone change request. There were no further comments, and the public hearing was closed at 6:44 pm.

7. CONSIDERATION AND POSSIBLE ACTION ON ZONE CHANGE REQUEST FROM C-2 GENERAL BUSINESS DISTRICT TO PD- PLANNED DEVELOPMENT DISTRICT FOR 16.91 ACRES OUT OF LOT 1, BLOCK 9 BEAKLEY SUBDIVISION.

Commissioner Lozano made a motion to deny the zone change request from C-2 general business

district to PD- planned development district for 16.91 acres out of lot 1, block 9 Beakley subdivision. The motion was seconded by Commissioner Martinez and passed unanimously.

8. PRESENTATION FROM FULCRUM ENGINEERING REGARDING DRAINAGE PROJECTS.

George Lazaro addressed the Commission regarding funding challenges for planned drainage projects. He explained that more funding from the Texas Water Development Board would be needed to complete the projects as intended. There was no action taken on this item.

9. <u>CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2023-20 DESIGNATING CITY CREDIT CARD SIGNATORY.</u>

Commissioner Martinez made a motion to approve Resolution 2023-20 designating Interim City Manager Frank Rios as City credit card signatory. The motion was seconded by Mayor Pro-Tem Guevara and passed unanimously.

10. <u>CONSIDERATION AND POSSIBLE ACTION ON CHANGE ORDER #5 WITH FOREMOST PAVING FOR STREET IMPROVEMENT PROJECT.</u>

Commissioner Lozano made a motion to approve Change Order #5 with Foremost paving for street improvement project. The motion was seconded by Commissioner Garcia and passed unanimously.

11. <u>CONSIDERATION AND ACTION TO APPROVE UPDATES TO THE CITY MANAGER</u> JOB DESCRIPTION.

Commissioner Lozano made a motion to approve updates to the City Manager job Description. The motion was seconded by Commissioner Martinez and passed unanimously.

12. <u>CONSIDERATION AND ACTION TO APPROVE RFP NO. 2023-01 TO PROCURE AN</u> EXECUTIVE SEARCH FIRM FOR THE FILLING OF THE CITY MANAGER POSITION.

Commissioner Lozano made a motion to discuss this item in closed session. The motion was seconded by Commissioner Martinez and passed unanimously. There was no action taken on this item.
