4. PUBLIC COMMENTS

Carlos Ayala addressed the Commission regarding a petition to install speed bumps on Kubiski Road and his request for information.

5. CONSENT AGENDA:

a. APPROVAL OF MINUTES FOR CITY COMMISSION MEETING HELD APRIL 14, 2024.

Commissioner Garcia made a motion to approve the items under consent agenda as presented. The motion was seconded by Commissioner Martinez and passed unanimously.

6. CONSIDERATION AND POSSIBLE ACTION TO ISSUE A DISASTER DECLARATION RELATED TO TROPICAL STORM ALBERTO.

Commissioner Garcia made a motion to issue a disaster declaration related to Tropical Storm Alberto. The motion was seconded by Mayor Pro-Tem Guevara and passed unanimously.

7. CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2024-09 DENYING AEP TEXAS' RATE INCREASE.

Commissioner Martinez made a motion to approve Resolution 2024-09 denying AEP Texas' rate increase. The motion was seconded by Commissioner Garcia and passed unanimously.

Mayor Pro-Tem Guevara made a motion to approve Resolution 2024-10 to designate authorized signatories for the Texas Community Development Block Grant Program. The motion was seconded by Commissioner Garcia and passed unanimously.

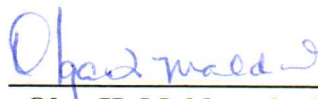
8. **DISCUSS AND CONSIDER ADOPTION OF A RESOLUTION 2024-11 AUTHORIZING THE SUBMISSION OF A TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION AND ADOPTING REQUIRED CDBG CIVIL RIGHTS POLICIES.**

Mayor Pro-Tem Guevara made a motion to approve Resolution 2024-11 authorizing the submission of a Texas Community Development Block Grant Program application and adopting required CDBG civil rights policies. The motion was seconded by Commissioner Garcia and passed unanimously.
